TRIP OVERVIEW

Please be advised that all tour participants must be in good physical health (completion of health questionnaire required). The tour also requires some mobility for participation in motorized canoeing activities as well as for maneuvering between decks on the ship itself. The Victoria Amazonica, while comfortable and air conditioned, is NOT a luxury yacht. The ship does not have elevators; the 2 decks are accessed via narrow stairway with handrails. Cabins consist of an upper and lower bunk bed. Only 2 single occupancy cabins can be accommodated; preference will be given to those willing to share. Full details of the ship's accommodations are provided for you on page 6, along with a separate insert featuring photographs of the ship.

This exciting journey for adventurers begins with an overnight stay at the Tropical Manaus Hotel, followed the next day by a morning tour of Manaus. From there, the group will board the ship, Victoria Amazonica, where we will spend the next eight nights.

We will depart from the pier of the Hotel Tropical on the Rio Negro in Manaus. At that place the river is six miles wide although over one thousand miles inland. The trip will

focus mainly on the beautiful Rio Negro with its black water. June is high water time so we will be able to make many canoe excursions into the tops of the trees of the floodplain forest.

The Rio Negro has many positives. It is beautiful with the mirror-like reflections in the water, but because it is very acid water there are no mosquitoes there and it is safe to swim in. We will also visit some of the small villages and towns along the river to learn about local life. Two days of the trip will be in the completely different ecosystem, that of the main Amazon river which has muddy water the colour of white coffee. Here we will see many birds and also be able to fish for piranha and other fish, but there will be a few mosquitoes. However the boat takes care to anchor away from the insects as far as possible. The high waters of June also diminish the number of insects. By visiting the two different rivers, one with black water and the other with white water, we will be able to see a huge variety of Amazon life. Iain Prance will tell you all about the plants and Anne will identify the birds and tell you about the people, and boat Captain Moacir Fortes is full of local knowledge, natural history and legends. The crew takes good care of you throughout the trip and you will enjoy many Amazonian foods, especially from the fish we catch.

Each day we make at least two excursions, some by large stable canoes and some on land in the forest or at villages. We tend to make an early morning excursion, come back on board during the heat of the day and then another in the late afternoon or even at night to watch the cayman and other nocturnal life.

HOTEL DESCRIPTION: Five Star Tropical Manaus Hotel



Guests arrive at this spot in the heart of the Amazon jungle to find the largest luxury hotel in Brazil. Located on the banks of the Rio Negro, Tropical Manaus is 10 miles from the center of Manaus. This property opened in 1976 and was expanded and remodeled in 1988, 1990 and 2006. It makes extensive use of dark Brazilian wood throughout the property. The large lobby features an atria bar with cafe tables and a conversation area. This space adjoins the business center and shopping arcade. Sitting and lounging areas are present on all floors where the halls intersect.

Dining options include the *Tropical Karu Grill*, which serves international and regional dishes including local fish; live music plays in the evening. The complimentary buffet breakfast is spread in the *Tucano Coffee Shop*, which also offers a la carte selections for lunch and dinner. A light snack menu is available in all the bars. The *Lobby Bar Tropical* proffers a wide selection of beverages, and the afternoon tea is accompanied by live music. A snack menu is available. *Bar Aquatico*, located by the main pool, has libations and snacks. Adjacent to the Tucano, *Cafe Brasil* serves drinks and snacks.

Elevators in two separate locations access the three floors of accommodations. Guests can select from colonial or modern decor with a choice of bed sizes. All accommodations are large with cable TV, desk, minibar, voice mail, blackout curtains, and a choice of garden or pool view. The combination tub-and-shower baths come with a hair dryer and standard toiletries. There are several suite options, with some offering a balcony, whirlpool and other upgrades. Two-level suites include a private rooftop pool, living room, dining room and two baths.

Guests can enjoy two pools, one of which is a wave pool. Further diversion can be found in the sports complex, jogging track, playground, volleyball court, children's club, five tennis courts and game room. A tour desk arranges transportation, tours and jungle adventures. The Tropical's zoo has a veterinarian and is approved to accept rescued wild animals.

The shopping court includes a drug store, beauty shop, and other tourist-related shops offering national and imported goods in a colonial setting. The hotel presents an elaborate folkloric show each week, and guests can choose to partake of the accompanying buffet.

Smoke-free and wheelchair-accessible rooms are in the mix. Segways are made available to guests as necessary. Room service runs round the clock.

SHIP DESCRIPTION: VICTORIA AMAZONICA

The Victoria Amazonica is a small 100 foot motorized vessel with 12 cabins that can accommodate up to 24 passengers plus crew. While not a luxury yacht, all cabins are air conditioned and have a private bathroom with a shower en suite. Please note that each cabin has a lower and UPPER bunk bed only. The dimension of the upper bed is 1.95 metres (6ft 4in) long and 1 metre (3 ft 3 in) wide. The lower bed is 1.95 metres long and 1.10 metres (3ft 7in) wide. The ship also has a Restaurant where meals are served as well as a small bar. The Victoria Amazonica has two decks, Main and Upper Deck which are accessed only by short, steep staircases with good hand rails.

Modern navigation equipment such as Global Positioning Systems, and satellite telephones, enable the crew to contact their home base with the ship's location at all times. Should they encounter a situation that might require assistance, engine parts, or transportation of clients to or from Manaus, they have an experienced bush pilot and float-plane standing by to provide whatever service is required.

The crew are professional, licensed mariners and our chefs are superb. Each boat driver brings along with them two kits. One with first aid medications and the other with motor tools in case the outboard motor breaks. The crew members are trained for simple medical emergencies. The "canoes" are 24 foot boats with outboard motors crewed by experienced guides for your daily trips into the interior. The crew are all river people, Coboclos, who are accustomed to the ways of the rainforest.

HEALTH & MOBILITY

All tour participants must be in good physical health. Although the Tropical Manaus Hotel has elevators, the Victoria Amazonica will require that all participants be capable of climbing up and down the stairs between the decks. Boarding in Manaus is from a dock and most landings are into a canoe. Although crew members are excellent at assisting guests on and off at all landings, it requires some mobility to get in and out of the canoes during the shore excursions. As with all our tours, tour members will be required to complete a Health Questionnaire which is signed by the tour member's physician.

VISAS:

Brazil requires a visa which must be issued through an approved visa service. To facilitate entry, Terra Nova Travel, will assist with obtaining all visas required for the group in advance of travel.

BAGGAGE ALLOWANCE:

The baggage allowance on regional and/or charter flights are restricted to 15kg and 20kg (depending on country visited) per person in a soft bag, plus a day bag with a reasonable amount of photographic or video equipment. Any excess luggage may result in a traveler facing the additional cost, which must be settled directly.

Cancellations & Refunds

Cancellations for bookings must be made in writing and effective upon receipt of written notification. Cancellations received before final payment will result in the forfeiture of your deposit. Trip Leaders

PROFESSOR SIR GHILLEAN PRANCE, F.R.S., V.M.H., M.A., D.Phil., F.L.S.

Ghillean Tolmie Prance was Director of the Royal Botanic Gardens, Kew from 1988 to 1999. Currently he is Scientific Director of the Eden Project in Cornwall and Visiting Professor at Reading University. He runs a conservation and research project for the Eden Project in the Yaboti Biosphere Reserve in Misiones, Argentina. In 2000-2002 he was McBryde Professor at the US National Tropical Botanical Garden in Hawaii and is now a McBryde Senior Research fellow there. Born in Suffolk, England on 13th July 1937, he was educated at Malvern College, Worcestershire and Keble College, Oxford where he obtained a B.A. in Botany (1960) and a D.Phil. in 1963 for his "Taxonomic Study of Chrysobalanaceae." He began his career with The New York Botanical Garden in 1963 as a research assistant, subsequently becoming B.A. Krukoff Curator of Amazonian Botany, Director and then Vice-President of Research, and finally Senior Vice President for Science in 1981. He also set up the Garden's Institute of Economic Botany of which he was the first Director from 1981-1988.

Sir Ghillean was trained as a plant taxonomist and has spent over eight years on field work and botanical exploration on 16 expeditions in Amazonian Brazil. He has a world-wide interest in the sustainable development of rainforest ecosystems and conservation generally; as well as being the author of nineteen books and editor of a further sixteen, he has published over 510 papers of both scientific (295) and general interest (196) on plant systematics, plant ecology, ethnobotany and conservation.

In addition to his various duties at The New York Botanical Garden, Sir Ghillean was the founder Director of graduate studies at the Instituto Nacional de Pesquisas da Amazonia (INPA) in Manaus, Brazil where he set up programmes in botany, ecology, entomology and ichthyology. He was an adjunct Professor of the City University at New York (1967-1998) and is a Visiting Professor at the University of Reading; from 1983-88, he was Visiting Professor in Tropical Studies at the School of Forestry and Environmental Studies of Yale University. He is a Fellow of the Linnean Society of London and was President 1997-2000, Fellow of The Royal Geographical Society, the Explorers Club and the American Association for the Advancement of Science, and has been President of the Association of Tropical Biology (1979-80), the American Association of Plant Taxonomists (1984-85), the Systematics Association (1989-1991) and the Institute of Biology (2000-2002.)

Sir Ghillean holds Honorary Doctorates from the Universities of Kent, Portsmouth, Kingston-upon-Thames, St Andrews, University of Bergen in Norway, Göteborg University in Sweden, Florida International University, Sheffield, Liverpool, Plymouth, Keele, Glasgow, Exeter, and Lehman College of City University, New York. He is a foreign member of the Academy of Sciences of Brazil, Denmark and Sweden; his honours include the Diploma Honora ao Mérito from INPA, Brazil (1978), the Distinguished Service Award of the New York Botanical Garden (1986), the Henry Shaw Medal of the Missouri Botanical Garden (1988), the Linnean Medal for Botany (1990), the Patron's Medal of the Royal Geographical Society (1994), the International Award of Excellence of the Botanical Research Institute of Texas (1998), Corresponding Member of the Botanical Society of America (1994), the Ordem Nacional do Mérito Cientifico: Grã-Cruz (Brazil) 1995 and the Order of Commander of the Southern Cross from Brazil in 2000. In 1993, he was elected a Fellow of the Royal Society and was awarded the International Cosmos Prize for his environmental work in Amazonia. He received the lifetime Discovery Award from the Royal Geographical Society and the Discovery Channel in 1999, the David Fairchild Medal for Plant Exploration jointly with his wife Anne in 2000 and the Allerton Award in 2005. He was knighted in July 1995, and received the Victoria Medal of Honour from the Royal Horticultural Society in 1999. He received the first Graziela Maciel Barroso Prize from the Brazilian Botanic Garden Network in July 2004. Sir Ghillean is married and has two daughters.

Lady Anne Prance

Lady Prance was born in Suffolk, England in 1939. She has a degree in English language and literature from London University. This has been put to use teaching English in private and university settings. She has travelled extensively and has lived in Latin America for extended periods of time, often in difficult and primitive conditions. She has co-authored books and articles with her husband and has published others alone. She has a wide range of international contacts arising from her charity work and her husband's work as Director of the Royal Botanic Gardens, Kew. She lives in southwest England now. She was chairman of Impact, a charity working to prevent and alleviate disability for five years and is still a trustee. She is chairman of the Bromley Charitable Trust. In January 2000 she was awarded, jointly with her husband the David Fairchild Medal for Plant Exploration. She and Sir Ghillean have two daughters; one is international director of the New Economics Foundation and the other is a surgeon in the South west of the UK. She is a keen bird watcher with a good knowledge of Amazonian birds.

The Family and History

We have always been a family owned and operated business. We carried explorers and adventurers up-river in small canoes for years and as the family grew, so did the boats Moacir Fortes ("Mo") has been exploring the Amazon River and its tributaries all of his life. His early experiences on the rivers were traveling with his father from town to town in the small boats that are still typical of the rural families today. Mo is a real pioneer in ecotourism, as he began leading small tours by motorized canoe in the 1980s. He quickly became popular with people from all over the world for his wit, personality and, of course, his tremendous knowledge of the Amazon, its wildlife and people (not to mention, knowing where to find the big peacock bass). Mo put his first ecotour boat, the *Cichla Ocellaris*, into service in 1990 and his business, Amazonia Expeditions, quickly grew. There is no one quite like Mo!
